3) Nomination and Election of TCC Chair & Vice-Chair Phil Conrad

INFORMATION: The Cabarrus-Rowan TCC Bylaws state that a new TCC Vice-Chair must be elected each year. The TCC Vice-Chair rotates to the Chair position automatically. In addition, the TCC Chair and Vice-Chair must be rotated between jurisdictions in Cabarrus and Rowan Counties. The TCC will need to nominate and elect a Chair from a jurisdiction in Cabarrus County for 2023 and a Vice-Chair from a jurisdiction in Rowan County for 2023.

<u>ACTION / RECOMMENDATION</u>: 1) Receive a report on the TCC Chair and Vice-Chair vacancies; and 2) Nominate and elect a TCC Chair and Vice-Chair for 2023.

4) Rider Transit Program of Projects (POP) Wendy Miller

INFORMATION: The Program of Projects is a list of proposed FTA grant requests to support the operations of Rider Transit in Fiscal Year 2023. Rider has elected to use the MPO Public Involvement procedures to process this annual requirement. No public comments were received during the comment period, which ended on November 7th. Attachment 4 is the POP.

<u>ACTION/RECOMMENDATION</u>: 1) Receive a report on Rider Transit's Program of Projects (POP); 2) Discuss; and 3) Request that the TAC consider endorsing the POP.

5) Performance-Based Planning: Safety Targets Phil Conrad

INFORMATION: The federal transportation legislation requires that State DOTs and MPOs adopt performance-based planning as a component of the metropolitan transportation planning process. The NCDOT has released the next round of safety targets for North Carolina and it is up to each MPO to either adopt these targets or devise their own targets. The proposed safety targets were published on the MPO's website. No public comments were received during the comment period, which ended November 7th. A draft resolution in support of the new safety targets for 2023 is included as attachment 5.

<u>ACTION/RECOMMENDATION</u>: 1) Receive a report on the NCDOT Safety Targets; 2) Discuss; and 3) Recommend that the TAC consider endorsing the Safety Targets.

6) FY 2020-2029 MTIP Modification #15 Wendy Miller

INFORMATION: MPO staff typically brings amendments or modifications from recent NCDOT Board of Transportation agendas to the TCC/TAC for consideration. The first project modification is the addition of the NC 49 access management improvements in FY 23 (HL-0062). The second project modification is the addition of the Caldwell Road extension in FY 23 (HL-0063). The third project modification is the addition of the US 29/Main Street improvement in FY 24 (HL-0064). The fourth project modification is the segmentation of the Old Concord Road sidewalk project (C-5603D). The fifth project modification is the segmentation of the Brenner Avenue sidewalk project (C-5603H). The sixth project is the segmentation of the US 601/Flowes Store Road intersection project (C-5603I). The seventh project is the delay of construction for the Brenner Avenue intersection project to FY 24 (HL-0049). The eighth project is the delay of right-of-way for the NC 24-27 and Bethel School Road intersection project to FY 23 (HS-2010D). The ninth project is the acceleration of right-of-way for the NC 24-27 and Pine Bluff Road intersection project to FY 23 (HS-2010F). The tenth project is the addition of Statewide Traffic Operations (H0-0010A). Attachment 6 is a resolution modifying the MTIP for these projects.

The September 21, 2022 meeting of the Cabarrus Rowan MPO TCC was called to order by MPO Director Phil Conrad. Director Conrad started the meeting by welcoming the members and called the roll of eligible TCC members and determined that a quorum was met. Director Conrad continued on by asking if there were any adjustments to the meeting agenda. Mr. Franklin Gover asked that an Item 7A – the allocation of funds to perform a planning study of US 152 Corridor be added to the agenda. Mr. Richard Smith made a motion to accept the addition to the agenda as presented and the motion was seconded by Ms. Susie Morris. Director Conrad continued by asking if there were any speakers from the floor. With no speakers being heard, Director Conrad moved to the next item of business.

Approval of Minutes

Director Conrad called the TCC members' attention to the meeting minutes of the August 17, 2022 TCC meetings included in their meeting packets. Director Conrad asked if there were any corrections or additions to the minutes. With no corrections or additions being heard, Ms. Susie Morris made a motion to approve the meeting minutes as presented. Mr. Richard Smith seconded the motion and the TCC members voted unanimously to approve.

NCDOT Request to Segment U-5706B

CRMPO Director Phil Conrad presented information on the request to segment the NC 73 widening project U-5706B. Director Conrad noted that with the release of the Draft STIP, it has become apparent that R-5706B or the NC 73 widening may face an uphill climb to gain funding in the near term. NCDOT staff is recommended segmenting this 11 mile project into 2 separate projects that would be scored and programmed independently. The break point would be at the I-85 interchange. NCDOT has been conducting an express design on this corridor to ascertain a better cost estimate. As noted this segmentation would require another project slot and additional points from the MPO and Division office to obtain funding in future STIPs. An email from Division 10 staff was included in the packet as attachment 3.

Mr. Stuart Basham, Division 10, discussed the project and noted that the A segment has funding for right-of-way in 2023 and construction in 2026. The B segment has been stalled and was caught in the 2019 funding shut down. Right-of-way is unfunded and the construction costs have increased significantly to \$70 million. The proposed segmentation is BA from Poplar Tent Road to I-85 and BB from I-85 to US 29/NC 601. The cross-section is four-lane with a median. The segmentation is expected to increase the project scoring. An additional slot for scoring will be required in addition to the current U-5706B slot. Mr. Conrad asked if committed projects are required to use an additional slot? Mr. Argabright noted that because the U-5706B project was not committed in either the draft STIP or re-released STIP, it isn't considered committed. Mr. Conrad said the project was committed at one point in the past but the right-of-way slipped. Mr. Argabright said that even if a project was once committed, it can fall out due to cost increases but the SPOT group will need to know this is a carry forward project. Mr. Basham said Division 10 will coordinate with the SPOT group to create the split and pointed out that the project should score well. Mr. Conrad noted that assigning points will come later and require additional points for 2 separate projects.

Mr. Phillip Graham made a motion to recommend that the TAC consider endorsing segmentation of the NC 73 widening (U-5706B) from Poplar Tent Road to US 29/NC 601 and Ms. Susie Morris seconded the motion. The vote was unanimous.

FY 2020-2029 MTIP Modification #14

Director Phil Conrad reminded the TCC members that the MPO staff typically brings amendments or modifications from recent NCDOT Board of Transportation agendas to the TCC/TAC for consideration. The project modification is the delay in construction to FY 24 for the North Washington Street sidewalk (BL-0043). Ms. Erin Burris with the Town of Mount Pleasant noted that the town needed more time for the project and the construction will only be delayed by one year. With no questions or comments, Ms. Erin Burris made a motion to recommend that the CRMPO TAC consider endorsing Modification #14 to the FY 2020-2029 MTIP. Mr. Phillip Graham seconded that motion and the TCC members voted unanimously to approve.

Proposed STPBG Call for New Projects

Director Phil Conrad explained that the MPO issued a call for project proposals for the STPBG funding source to the MPO. The call concluded on September 2nd. Staff received a total of 5 project requests from 3 project sponsors. The total cost of these projects is \$35.5 million. Director Conrad reviewed the STPBG funding allocations available through 2033 and noted that the balance of funds requested is within the allocation. Mr. Ed Muire asked about the table and wanted clarification about the federal funding versus the total. Mr. Graham pointed out the \$44 million includes the local match. The project sponsors presented information about the 5 projects.

Mr. Philip Graham of Concord discussed the Derita Road widening and the overruns experienced due to the extensive utilities issues which doubled the cost of the project. Mr. Muire asked Mr. Graham if the City of Concord had been aware of the match in meeting the cost overruns, if they would have committed to the project. Mr. Graham said he couldn't speak for the elected officials but likely yes as the project is needed for the area. Mr. Muire was concerned about the likelihood of this happening in the future and the precedent that this sets. He asked if someone saw this coming and was there an opportunity to consider the situation earlier in the process. Mr. Graham said it was unfortunate and from his conversations with Division 10, this project was the worst NCDOT has seen. Mr. Basham said that the utilities were a big problem on the project as well as cost increases on materials. The Department didn't realize the magnitude of the overruns until close to the end of the project which correlated with the COVID 19 shut downs. He said it was definitely an anomaly and there are now processes in place internally to do more frequent cost estimates, however, fluctuations in the market are still out of NCDOT's control. Mr. Basham noted that Division 10 is trying to meet the City in the middle.

Ms. Mallory Hodgson of Harrisburg presented their three projects. The NC 49 corridor safety project includes medians, turn lanes, driveway closures, improved pedestrian access and other aesthetic improvements. The Hickory Ridge Road Sidewalk project has a number of challenges including creek crossings and the bulk of the cost of the project is a separate pedestrian bridge. There is also a connection to the greenway project. Mr. Conrad noted that this project would likely be considered for future TAP funding. The Caldwell Road Extension Phase 1 is a future 2 lane median divided road with a ten-foot pedestrian side path. The proposed project is a 3,000 feet segment north from the intersection with NC 49. The expectation is that developers will complete the connecting road to US 29. Ms. Morris asked if the total distance of the road is 2.5 miles and how this project fits into the Morehead West/Harrisburg Area Plan. Ms. Hodges said the project is part of the plan to connect NC 49 to US 29. Ms. Loretta Barren asked if this project is on the Federal Aid system. Mr. Conrad noted Caldwell Road is not, however there may be a way to swap for State Trust funds. Mr. Argabright asked if the facility would be on the State system. Ms. Hodgson said Caldwell would remain a City street. Mr. Argabright noted that the road would need to be functionally classed as more than a local street. Ms. Barren said she is not sure the project will qualify for federal funds. Mr. Fred Haith asked if there is a path to eligibility for the project. Ms. Barren said the project needs to have the connectivity and be a full project. Mr. Conrad said there needs to be additional discussion on the project and wanted to be sure he had the correct total of \$6 million. He will adjust the table accordingly and the town will remove the Hickory Ridge Road sidewalk project and bring it back for TAP funds during that upcoming call for projects.

Ms. Wendy Brindle of Salisbury presented the Salisbury Main Street safety improvement project. She noted that the project has had extensive community input and the City Council adopted the concept plan for a total of 17 blocks of safety, parking, striping, pedestrian safety and landscaping improvements. This project is a 6-block portion in downtown. The project request is for \$7.4

million. Mr. Gover asked if the City has budgeted for the project design. Ms. Brindle said the RFQ for the design is being released in October.

Director Conrad asked for questions or comments. Mr. Muire asked if the vote on the projects should be individual or a package. Mr. Conrad said it could be as a package. Mr. Gover asked if the vote should wait until October to determine the Caldwell Road eligibility. Mr. Conrad said that staff will work on the Caldwell Road eligibility between now and the TAC meeting. Ms. Mallory Hodgson made a motion to recommend that the TAC consider endorsing the four STPBG projects for funding with the possibility that the Caldwell Road project may not qualify for STPBG funds. Mr. Phillip Graham seconded the motion and the vote was unanimous.

Proposed STBG-DA Fund Swaps

Director Conrad introduced Mr. Van Argabright with the NCDOT STIP unit. Mr. Argabright discussed the STBG-DA program which began in the mid-1990s to allow large MPOs designated as Transportation Management Areas (TMAs) to direct how these federal dollars should be spent. The funds are part of the state's federal apportionment and flow to the MPOs through NCDOT. The MPOs developed processes to call for projects and administer the funds through the Local Programs Division units. The complex rules to use federal funds can slow down the delivery of projects with local jurisdictions. The delays result in NCDOT being unable to obligate the state's funds and creates unobligated balances and limits the amount of funds NCDOT can request before the August Redistribution. This year NCDOT was able to obligate funds and will receive \$277 million in August Redistribution from the federal government. To increase the amount NCDOT can request during the August Redistribution and to aid local jurisdictions in administering projects, NCDOT is proposing to swap unobligated and future programmed STBG-DA funds in the CR MPO. There are two options to fund swap – most highway projects which are eligible for state trust funds and bicycle and pedestrian project eligible for STBG Any Area funds. The benefits are that it is simpler for local jurisdictions to deliver projects with state funds, a larger pool of highway projects can be considered for CR MPO discretionary funds, and matches and schedules remain the same. Previous swaps allowed NCDOT to receive \$127 million more in August Redistribution than would have otherwise been available.

NCDOT is preparing for 2023 August Redistribution and is planning to obligate as much as possible in each federal funding category through fund swaps and obligating all TAP and CMAQ funding. NCDOT is requesting a swap of \$12 million in CR MPO STBG-DA funds for FY 2023 and 2024 for the I-5858 Interstate 85 Pavement Rehabilitation in Salisbury (\$6,466,885) and U-4910 Derita Road Widening in Cabarrus County (\$5,533,115). Mr. Conrad asked about using the the STBG Any Area funds through the STI. Mr. Argabright noted that state funds are easier to use and open more project options such as the Caldwell Road project could have been funded if it was a state route. He said they are starting the swap early to be prepared for next August redistribution.

Director Conrad asked for questions or comments. Mr. Phillip Graham made a motion to recommend that the TAC consider endorsing the proposed STBG \$12 million funding swap with the two CR MPO projects in FY 2023 and 2024. Mr. Fred Haith seconded the motion and the vote was unanimous.

Proposed NC 152 Corridor Study with PL Funds

Director Phil Conrad invited Mr. Franklin Gover from the Town of China Grove to present the NC 152 Corridor Study request. Mr. Gover presented the Town of China Grove's request to do a study of the NC 152 corridor at Exit 68 with planning funds. The industrial growth in the area around Exit 68 has been booming and the traffic counts have been increasing significantly. The Town of China Grove is requesting \$60,000 in PL funds to accomplish the study. Mr. Conrad asked if the Town has the local match budgeted. Mr. Gover replied that the Town does.

Director Conrad asked for questions or comments. Mr. Conrad pointed out there is already a study for South Main Street underway and the study funds would flow through the City of Concord Finance Department. Mr. Conrad said there may be other study needs and other communities with similar requests pending and that these additional studies would require an amendment to the UPWP. Mr. Richard Smith made a motion to recommend that the TAC consider allocating \$60,000 in PL funds to China Grove to undertake a planning study of the NC 152 Corridor at Exit 68. Mr. Fred Haith seconded the motion and the vote was unanimous.

Reports/CRMPO Business

<u>1. Local Reports</u> – MPO/NCDOT Division 9 and 10/PTD - Mr. Fredrick Haith, NCDOT Mr. Stuart Basham, NCDOT Division 10 representative called the TCC members' attention to a spreadsheet of Division 10 project updates and highlighted some of the ongoing projects in Division 10. Mr. Basham noted that U-3440 is 89% complete with opening scheduled for April 2023, Centergrove Church Road is 93% complete with an October opening, S. Lentz Harness Shop Road is 61% complete and opens in December, Miami Church Road over Dutch Buffalo Creek has been awarded with completion in May 2023, and NC 24/27 in Locust has been let with completion in July 2023. Mr. Basham stated that NCDOT Division 10 will hold a week of drop-in meetings on the draft STIP from September 26th through 30th at the Division 10 offices at 716 W. Main Street, Albemarle.

Mr. Fred Haith, Division 9 representative called members' attention to the Division 9 spreadsheet included in their packets. Mr. Haith noted that the Division 9 will hold a week of drop-in meetings on the draft STIP from October 3rd through 7th at the Division 9 offices at 375 Silas Creek Parkway, Winston-Salem. He reported he had no additional information to report but would gladly answer any questions.

2. Rowan Transit System Section 5310 Grant Application Letter of Support – Director Conrad introduced Ms. Valerie Steele to report on behalf of the Rowan County Airport and Transit Authority. Ms. Steele presented the Section 5310 grant application for Enhanced Mobility for Seniors and Individuals with Disabilities. The request is for \$375,000 with 50% from the grant and 50% match from contract revenue. The funds support Rowan Vocational Opportunities Inc, Trinity Living Center and Davita Kidney Care. Mr. Conrad noted that the letter of support is in the agenda packet and will be included for consent in moving forward to the TAC in September.

<u>3. TAP Fund Project Call</u> - Mr. Conrad informed the members that the TAP Fund Call for Projects will be issued soon and the deadline will be November 30th. There is \$4.1 million in funds available for TAP projects and Harrisburg's sidewalk project is already in the queue.

<u>4. Special Studies Update- Rowan County and Town of China Grove</u> - Mr. Franklin Gover reported that the Town of China Grove Main Street Corridor Study is underway and the public input portion is complete with a community survey on the project. The town is working on recommendations with the consulting team and will hold a community charrette on October 31st.

<u>4. Rider Transit Program of Projects</u> – Director Conrad presented the Draft Rider Program of Projects located in the agenda packet. Staff met with Andy Christy, Rider Transit Manager, to review the transit Program of Projects which will go out for public comment from October 3rd through October 31st. The Program of Projects will come back to the MPO for approval in January 2023.

5. MPO Newsletter – Ms. Wendy Miller reported on the upcoming Fall 2022 CR MPO Newsletter which will include information on the adopted 2050 MTP, the re-release of the STIP, updates on project data for the Airport Parkway, Spencer Greenway, and other projects as well as the project selection process for the STBG-DA funds and Call for TAP and Carbon Reduction Program (CRP) funding. MPO staff would like to hear of other projects or programs of interest by the TCC member jurisdictions.

6. Proposed GHG Performance Measure by FHWA – Federal Register Comments due October 13th - Ms. Wendy Miller provided information on the Greenhouse Gas Performance Measure and Emission Targets. On July 7, 2022, FHWA announced Notice of Proposed Rulemaking for states and municipalities to track and reduce greenhouse gas (GHG) emissions. The Rulemaking proposes to amend regulations governing National Performance Management Measures to require State DOTs and MPOs to establish declining carbon dioxide (CO2) targets and a method for the measurement and reporting of greenhouse gas (GHG) emissions associated with transportation under the Highways title of the United States Code.

The performance measures will apply to States and MPOs with National Highway System (NHS) mileage within their geographic boundaries and they have flexibility to set targets appropriate to their communities as long as the targets reduce emissions over time. The proposed rule requires biennially reporting on progress and requires FHWA to assess significant progress toward achieving the targets. FHWA will not mandate reduction target levels and MPOs may use alternate methods such as the regional Travel Demand Models (MOVES) to calculate GHG emission reductions. The goal is to reach net-zero by the year 2050. Comments on the Rulemaking are due by October 13, 2022 thru the Federal Register.

MPO staff will consider submitting Federal Register comments on the proposed Rulemaking on the Greenhouse Gas Emissions Measure as the national AMPO will be submitting comments. A timeline for establishing the baseline targets and reporting may be adjusted based on Rulemaking comments before the final Rulemaking is promulgated by FHWA. Mrs. Loretta Barren with FHWA pointed out that the MPO will be required to coordinate with both NCDOT and with CRAFT in developing a joint regional target. She encouraged the MPO to consider commenting on the joint target aspect of the Rulemaking.

Background

The annual Program of Projects is a list of projects proposed to be funded in a given fiscal year from Federal Transit Formula Grants, any transit discretionary grants, any Federal Highway Funds flexed to FTA for transit improvements, and state formula grant programs. Such projects must also be identified in the MPO-approved Metropolitan Transportation Improvement Program or the Unified Planning Work Program to be eligible for inclusion in the Program of Projects. The Program of Projects provides an additional opportunity for the public to learn about and comment on planned transit grants for the fiscal year.

The Program of Projects may be developed and approved by the designated recipient (the City of Concord - Rider Transit System) or the Metropolitan Planning Organization. The MPO is responsible for the MTIP and the UPWP, and therefore, Rider Transit has elected to use the MPO's public comment process for its program of projects. There are multiple recipients of Federal Transit grants operating in the MPO area (Salisbury Transit and NCDOT for Cabarrus County and Rowan County). The MPO must follow the Public Participation Plan, which for the Program of Projects requires a 28-day public comment period.

FY 2023 Program of Projects

The FY 2023 Program of Projects includes anticipated FTA formula grants under the following programs: Section 5303 Metropolitan Planning, Section 5307 Urbanized Formula, Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities, and Section 5339 Bus and Bus Facilities.

The FY 2023 Program of Projects also includes State Maintenance Assistance Program (SMAP) funds administered by NCDOT.

The Program of Projects also describes funds made available to subrecipients and grant details such as a description, federal funding amount, and matching funds amounts. The proposed program as identified in the Draft Program of Projects will be the final program unless amended.

The MPO will seek public input on the Program of Projects under the MPO Public Participation Program. This includes a 28-day public comment period and a public review to be held at the November 30 TAC meeting. The Transportation Advisory Committee will be the body to approve the document.

Recommended Action: MPO Approval at the November 30 meeting.

Endorsement of Targets for Safety Performance Measures Established By NCDOT

WHEREAS, the Cabarrus-Rowan MPO has been designated by the Governor of the State of North Carolina as the Metropolitan Planning Organization (MPO) responsible, together with the State, for the comprehensive, continuing, and cooperative transportation planning process for the MPO's metropolitan planning area; and;

WHEREAS the Highway Safety Improvement Program (HSIP) final rule (23 CFR Part 490) requires States to set targets for five safety performance measures by August 31, 2022, and;

WHEREAS, the North Carolina Department of Transportation (NCDOT) has established targets for five performance measures based on five year rolling averages for: (1) Number of Fatalities, {2) Rate of Fatalities per 100 million Vehicle Miles Traveled (VMT), (3) Number of Serious Injuries, (4) Rate of Serious Injuries per 100 million VMT, and (5) Number of Non-Motorized {bicycle and pedestrian} Fatalities and Non-motorized Serious Injuries, and;

WHEREAS, the NCDOT coordinated the establishment of safety targets with the 19 Metropolitan Planning Organizations (MPOs) in North Carolina through a Safety Target Setting Coordination Training Workshop held in March, 2017, and;

WHEREAS, the NCDOT has officially established and reported the safety targets in the Highway Safety Improvement Program annual report dated August 31, 2022, and;

WHEREAS the MPO's may establish safety targets by agreeing to plan and program projects that contribute toward the accomplishment of the State's targets for each measure, or establish its own target within 180 days of the State establishing and reporting its safety targets in the HSIP annual report.

NOW THEREFORE, BE IT RESOLVED, that the Cabarrus-Rowan MPO Transportation Advisory Committee (TAC) agrees to plan and program projects that contribute toward the accomplishment of the State's targets as noted below for each of the aforementioned performance measures:

- For the 2023 Highway Safety Improvement Plan (HSIP), the goal is to reduce total fatalities by 19.57 percent each year from 1,494.8 (2017-2021 average) to 1,202.2 (2019-2023 average) by December 31, 2023.
- For the 2023 Highway Safety Improvement Plan (HSIP), the goal is to reduce the fatality rate by 20.95 percent from 1.279 (2017-2021 average) to 1.011 (2019-2023 average) by December 31, 2023.
- For the 2023 Highway Safety Improvement Plan (HSIP), the goal is to reduce total serious injuries by 30.19 percent from 4,903.4 (2017-2021 average) to 3,423.0 (2019-2023 average) by December 31, 2023.
- For the 2023 Highway Safety Improvement Plan (HSIP), the goal is to reduce the serious injury rate by 31.75 percent from 4.195 (2017-2021 average) to 2.863 (2019-2023 average) by December 31, 2023.
- For the 2023 Highway Safety Improvement Plan (HSIP), the goal is to reduce the total non-motorized fatalities and serious injuries by 26.52 percent from 637.2 (2017-2021 average) to 468.2 (2019-2023 average) by December 31, 2023.

Background

Effective April 14, 2016, the Federal Highway Administration (FHWA) established five highway safety performance measures in accord with regulations set forth in the Federal MAP-21 and FAST Act transportation funding bills. These performance measures are:

- 1. Number of fatalities;
- 2. Rate of fatalities per 100 million vehicle miles traveled;
- 3. Number of serious injuries;
- 4. Rate of serious injuries per 100 million vehicle miles traveled; and
- 5. Number of combined non-motorized fatalities and non-motorized serious injuries.

These targets are established annually, are based on 5 year rolling averages, and are for calendar years. North Carolina state targets are set in agreement with our <u>Strategic Highway Safety Plan (SHSP)</u> goals. The SHSP goals are developed through collaborative efforts of a diverse group of stakeholders including state, regional, and local partners (including MPOs). The goal of the most recent (2019) SHSP is to reduce fatalities and serious injuries by half by 2035, moving towards zero by 2050.

North Carolina Safety Performance Target Achievement Determination

Earlier this year, FHWA completed an assessment of target achievement for NCDOT's calendar year (CY) 2020 safety targets, based on the 5-year averages for 2016-2020 for each measure. As per 23 CFR 490.211(c)(2), a State Department of Transportation (DOT) has met or made significant progress towards meeting its safety performance targets when at least four of the safety performance targets established under 23 CFR 490.209(a) have been met or the actual outcome

is better than the baseline performance. **Based on FHWA's review, North Carolina has not met or made significant progress toward achieving its safety performance targets.** As a result, NCDOT must ensure that all HSIP safety funds are obligated, and must develop an HSIP Implementation Plan that describes actions the State will take to meet or make significant progress toward achieving its targets. Table 1 below provides a summary of the target achievement determination at the state level.

Next Steps

MPOs are not directly assessed by FHWA on their progress towards meeting safety performance targets. However, coordination and deliberate action will be needed to achieve the goals outlined in the NC Strategic Highway Safety Plan and as communicated through the safety performance targets. We encourage additional coordination between MPO's and NCDOT Traffic Safety Unit in all areas of safety, but specifically in data sharing, safety tools development, safety need identification and shared safety project implementation. The Traffic Safety Unit is available to meet with your MPO for additional discussion and partnership.

FHWA guidance allows each MPO to establish safety performance targets by either agreeing to plan and program projects so that they contribute toward the accomplishments of the State DOT performance targets or committing to quantifiable HSIP targets for their specific MPO area. If an MPO establishes its own targets, it will need to do so in coordination with the State per FHWA guidelines. The Traffic Safety Unit is available to facilitate this coordination. As a reminder, MPOs must establish safety performance targets no later than February 27 of each year per FHWA guidance. Please transmit a signed adoption resolution indicating the establishment of safety targets for your MPO or supporting the state's targets to Daryl Vreeland (dvreeland@ncdot.gov) in the Transportation Planning Division just as you have in previous years. FY 2023 RAISE Grant Project Candidate Survey

Next month the USDOT will release the Initial Notice of Funding Opportunity (NOFO) for the 2023 RAISE Grants. The Final Notice of Funding Opportunity should be available on or before November 30th. The Integrated Mobility Division (IMD) is actively exploring projects that may be strong candidates for RAISE.

IMD is seeking your assistance in identifying potential projects, programs of projects or combined projects that meet the eligibility criteria for the USDOT RAISE grants. Please review the following considerations and submit potential candidate projects that meet some or all of these conditions, by Friday November 11, 2022, via the following Smartsheet survey: FY 2023 RAISE Grant Project Candidate Survey

IMD is seeking multimodal projects that improve equitable connections to transit and bicycle & pedestrian facilities. Overall selection criteria for RAISE grants include safety, environmental sustainability, quality of life, economic competitiveness, and state of good repair. The secondary selection criteria includes partnerships and innovation. Projects should include components that reduce emissions, promote energy efficiency, increase resiliency, and recycle or redevelop existing infrastructure.

When completing the survey, be sure to attach supporting documents for projects (RAISE applications if you submitted an application in the past, BCA, plans/drawings, letter of support, etc.) Funding sources should be identified for the project. NCDOT may be able to provide match for transit components or complete streets components that are already committed in the STIP. Local match (non-Federal and nonstate) would be required for independent bicycle & pedestrian projects.

Projects can be combined into a program of projects, potentially covering a broader region, as long as each project has independent utility.

NCDOT began initiating Phase 1 of the plan in October 2022 while also commencing foundational public engagement work for Phase 2. The team will work with market participants and community stakeholders to ensure the charging infrastructure is deployed in an equitable,

Subject: Cabarrus-Rowan MPO, Federal FY23 Carbon Reduction Program Allocation

Dear Mr. Conrad:

On November 15, 2021, President Biden signed the Infrastructure Investment and Jobs Act (IIJA) (Public Law 117-58, also known as the "Bipartisan Infrastructure Law") (BIL) into law. The BIL authorizes a new Carbon Reduction Program (CRP) codified at 23 United States Code (U.S.C.) 175 to reduce transportation emissions. The Transportation Planning Division is pleased to inform you that the following funds have been made available to the Cabarrus-Rowan MPO, through the CRP. For Federal FY23, the Cabarrus-Rowan MPO will receive the allocation of \$490,891 in federal funds.

CRP funds are available for obligation for a period of 3 years after the last day of the fiscal year for which the funds are authorized (*See* 23 U.S.C. 118(b)). Thus, CRP funds are available for obligation for up to 4 years. The federal share for CRP funded projects is 80% and will require a 20% non-federal match for projects.

Cabarrus-Rowan MPO is a TMA area and has selection authority per 23 CFR 450.332(c) but should coordinate with NCDOT on which projects are selected to ensure eligibility.

CRP funds can be used for a wide range of projects that reduce emissions. Eligible activities as identified in the statue are as follows: traffic management, truck stop electrification, public transportation, transportation alternatives, advanced transportation and congestion management technologies, intelligent transportation systems, development of a carbon reduction strategy, travel demand management, efforts to reduce the impacts of freight movement, deployment of alternative fuel vehicle, diesel engine retrofits, traffic flow improvements that do not involve construction of new capacity; and projects that reduce transportation emissions at port facilities. Other projects may be eligible with demonstration of emissions reductions. All projects selected must follow Title 23 requirements.

For additional guidance as next steps, we recommend you follow the listed of steps below.

- Identify a list of projects that are eligible in your area. (Minimum project cost is \$100,000.)
- Develop a process for making sure that projects are distributed equitably if you have more needs than funds.
- Identify and ensure that the local government has the 20% local match available and that the total project cost includes an additional 10% for NCDOT project oversight.
- Once you have identified the projects that you would like to fund with CRP funds, email NCDOT-TPD the projects information to confirm eligibility.
- Once NCDOT- TPD has reviewed and confirmed eligibility of projects and issued a CRP Verification Letter with STIP identifiers, then steps should be taken to incorporate in MTP and STIP through the amendment process.
- Once your MPO has received confirmation of project eligibility, the jurisdiction administering the project would then contact NCDOT Local Programs to establish a funding agreement (instructions on how to do this will be in the award letter).
- Once the funding agreement is established and federal funds authorized, project manager follows the process detailed in the <u>Local Programs Management</u> <u>Handbook</u>.

CR MPO 2050 Metropolitan Transportation Plan Update

The Metropolitan Transportation Plan (MTP) defines the transportation vision to be implemented over the next 25 years which will improve our 2 county area transportation system by reducing congestion, increasing safety, providing mobility choices for all citizens. Projects are shown by implementation phases or "open for traffic" as indicated by the three horizon years of 2035, 2045, and 2050.

The 2050 MTP includes updates to all chapters of the document with new information on the Federal Infrastructure Investment and Jobs Act (IIJA) as well as new NCDOT Complete Streets guidance for locals. For the first time, the MPO performed additional analysis of the Existing and Future Conditions of the Cabarrus Rowan MPO roadways with a more in depth study of the facilities over capacity in the base and 2050 horizon year. Peak hour travel congestion for the 2050 horizon year of all existing and committed projects provided a snapshot highlighting areas of concern for improvements, which was integrated into the Congestion Management analysis chapter. In addition, the MPO unveiled a new detailed study of roadway safety analysis including hot spot and bicycle and pedestrian crash data throughout the MPO area by US Census block. The final 2050 MTP is available on the MPO website at www.crmpo.org.

Town of Spencer Greenway - EB-5861

Initially envisioned as a pedestrian connection from a planned greenway system along Grants Creek, into downtown Spencer, and then out to the Yadkin River at the Wilcox Bridge, the STIP project EB-5861 was visionary. With completion of some nodes, the EB-5861 "link" has been refined to tie various important points of interest including three public schools located in northern Rowan, important commercial and recreational development around the Wilcox Bridge at the Yadkin River, and will leverage the value of any single point of interest into what will become a regional attraction. EB-5861 would also extend trails from the 7th Street Trailhead, along Grants Creek and connect to the City of Salisbury's existing greenway system west of Old Mocksville Road. In its initial planning phases started almost a decade ago, EB-5861 was funded at approximately \$3.5 million with the Town providing a 20% local match. That cost did not include right-of-way acquisition, design and engineering, or project management expenses. Today's cost estimates have grown dramatically from those original numbers, with rough estimates for the initial phases north of \$15 million. With \$3.5 million still available from EB-5861 funding sources, the Town intends to pursue other discretionary funds and local private sources to complete this important project.

Federal Transit Funds - Section 5310 Elderly and Disabled

The goal of the Federal Transit Administration (FTA) Section 5310 program is to improve mobility for older adults and people with disabilities throughout the Concord Urbanized Area and to enhance coordination of federally assisted programs and services. Under the 5310 program, the area transit is encouraged to coordinate transportation services with agencies that provide transportation services to the general public within the service area/network.



- CCTS provides over 66,634 total trips/year
- A fully allocated cost per trip is \$18.00
- Over 15,000 trips are Senior Trips (19%)
- 2,022 Senior Citizen clients in the database
- 403 (13%) ride under Section 5310
- The 5310 Grant provides an additional 22,612 trips

The North Carolina Department of Transportation (NCDOT) released a revised Draft 2024-2033 State Transportation Improvement Program (STIP) to MPOs in August 2022. The revised STIP includes approximately \$5 billion in additional funding for transportation projects throughout North Carolina from the sales tax revenue transfer provision within the state budget over the next ten years. This resulted in the inclusion of additional projects that were initially identified as 'unfunded' or 'funded for preliminary engineering only.'

Surface Transportation Block Grant Projects

During the spring, the MPO issued a call for project proposals for the Surface Transportation Block Grant (STBG) funding source to the MPO. The call concluded on September 2, 2022. Staff received a total of five project requests from three project sponsors with a brief description of four of those projects provided in the table below.

The Derita Road project was requested by NCDOT to cost share with the City of Concord for the overruns on the project. A bicycle and pedestrian project known as the Hickory Ridge Road Sidewalk Extension in the Town of Harrisburg was recommended for submittal during the current call for the Transportation Alternatives Project funding.

At the September 28th meeting, the MPO awarded \$26,853,780 in STBG funds to the four projects below.

Potential project sponsors should refer to the TAP process document and contact MPO staff if you have questions about the application process or project eligibility. Project applications are scheduled to be reviewed and approved by the MPO Board at the January 25, 2023 meeting.

If your organization would like to submit a project for funding consideration, please complete the application and submit it no later than **November 30, 2022**. Applications received after that date will not be considered. Accept formats for applications are electronic or printed. Please call (704) 791-0608 to verify receipt of your application.

Carbon Reduction Program

The Infrastructure Investment and Jobs Act (IIJA) enacted on November 15, 2021, established the Carbon Reduction Program (CRP) to reduce transportation emissions from on-road sources. The CRP requires each State, in consultation with their MPOs, to develop a carbon reduction strategy and identify projects and programs to support reduction of transportation emissions. The options may include reducing congestion by facilitating modes other than single occupant vehicles, promote the use of vehicles or modes that lower emissions per person per mile, and facilitate transportation construction approaches that result in lower emissions.

The CR MPO will receive funding for FY 2022 through 2026 with a FY 2022 allocation of \$481,266. The CRP funds require a 20% local match and 10% of the total project cost for NCDOT oversight. The CR MPO will coordinate with NCDOT to confirm project eligibility and incorporate the projects into the MTP and STIP. The CR MPO intends to hold a Call for Projects soon and work closely with NCDOT to implement selected projects.

- **1. Welcome & Introduction:** Stephen Allen, CRCOG began the online zoom meeting at 10:00 AM and welcomed everyone in attendance.
- 2. Approval of May 24, 2022 Minutes: Mr. Allen asked if there were any corrections, additions and / or deletions to the May 24, 2022 minutes. Ms. Gates proposed a minor change. Ms. Gates made motion to approve, Mr. Cook Seconded motion. Approved unanimously.
- **3. CRAFT Workplan Agenda for FY21-22:** The meeting was led by Mr. Allen who led the group through an in-depth discussion of the 2022-2023 workplan. Mr. Allen walked through each of the four main topic areas of the workplan to include administrative, planning & project coordination, planning studies/initiatives, and legislative/grant planning, seeking open input from the members. Mr. Allen received significant input from the members during the discussion, making live changes to the plan during the meeting. The following changes/notes were made and are divided by the bold highlighted section below, the remainder of the document remained as-is:

Administrative:

- Technical Committee (TC): The TC would continue to meet on the 4th Tuesday of every other month and continue the same hosting schedule.
- Executive Committee: It was decided that the Executive Committee would only schedule a meeting as needed.
- Added possible discussion of the semi-annual work program discussion to the January mid-point review.

Planning and Project Coordination:

- Metropolitan Transportation Plan: This item is scheduled as a reoccurring agenda item (as needed) at each meeting.
- TPM: Keep September as an agenda item. Removed CMAQ hold for November
- TIP Project prioritization (NC Only): added as needed per meeting.
- CTP/Thoroughfare Planning: added as agenda item as needed per meeting.

Planning Studies / Initiatives:

- Regional Freight Mobility Plan:
 - Regional Strategic Freight Plan (Further implementation studies) (Under Redevelopment) added to the January meeting.
- I-77 Corridor Study: Removed.
- Added Regional Transit Plan Implementation (Connect Beyond): (M. Nance and J. Wager) Added as needed per meeting.
- CAV Task Force: Discussion items were moved from November to September.
- Removed North BRT Study item.
- Removed Major Investment Study item.
- Removed Catawba Crossing Feasibility Study
- Strategic Planning CRPTO: This item is scheduled for January
- Added CATS Update as needed planning item per meeting.

Legislative Grant Planning

- Removed Federal Transportation Act Reauthorization (America's Transportation Infrastructure Act).
- Added Infrastructure and Jobs Act of 2021 as needed.

The consensus of the group is to use the matrix to plan future CRAFT meeting agendas over the next 12-month period.

4. MTP Amendments update – Neil Burke:

Mr. Burke provided a detailed update on funding the NC STIP. He indicated that the state would add \$4-6 Billion to transportation projects over the next ten years, which will help reduce some of the state transportation funding gaps. The Draft STIP is being reprogrammed to account for the new funding availability. The updated Draft STIP will be available in August. All MTPS with projects delayed by funding issues will need to be updated, reflecting the new funding amendments provided for in the new draft STIP.

5. Connect Beyond Update – Jason Wager:

Mr. Wager discussed Centralina contracting with NCDOT for the FY23 TDM grant and is also working with NCDOT to engage a consultant to assist with a regional TDM Plan. Mr. Wager discussed the Connect Beyond staff participating as panelists at national and state conferences.

Jason Lawrence, CATS introduced Brian Horton as a new staff from CATS.

Mr. Wager then discussed the Carbon Reduction program and the project team's effort to look at opportunities to implement connect beyond actions, including developing a regional TDP plan. He also discussed the next steps for advancing the plan.

6. Other Business:

Loretta Barren, FHWA inquired with David Hooper, RFATS into conformity budgets under the new Moves model. Mr. Hooper indicated that RFATS has had no issues.

Robert Cook, CRPTO advised the group that CRTPO Board decided to stick with the PHEAD and Non-SOV travel targets for the upcoming performance period.

- 7. Next Meeting Date: Mr. Allen noted that the next meeting is scheduled for September 27, 2022, and will be hosted by CRPTO. Mr. Cook asked the group if they objected to an inperson meeting.
- 8. Adjournment: The meeting adjourned at approximately 10:58 am.
